- In view of the above, it is to submit that senior most employee in the cadre of Assistant Secretary has put up lengthy service and is having vast experience in addressing IR issues more efficiently and it was our humble request that the said Assistant Secretary be considered for promotion as Deputy Secretary duly counting against General Manager (IR) post, as there are no personnel utilize the post of GM (IR).
- But surprisingly, the APGENCO Management has restored the General Manager (IR) post to Corporate Office from RTPP further re-designated the nomenclature as GM (HR) . Further, the Management has issued promotion orders to one of DGM (HR) personnel in HR stream as GM (HR), without taking into consideration of our association request.
- We also bring to your kind notice that, the senior in the cadre of Assistant Secretary has rendered more length of service than the newly promoted GM/HR as a result the P&G Personnel after putting up years of service and acquiring vast experience, are being deprived their privilege.

We therefore, request the Hon`ble Special Chief Secretary to Government, Energy Department to immediately re-examine the issue and cause necessary instructions for favorable action in the matter.
